Focusing his practice on eminent domain matters, litigator Michael "Mike" Bauscher advises municipalities and public-benefit corporations that are using condemnation law to acquire interests in real property, guiding them in the planning process for acquisition of properties by eminent domain, the public hearing process, the commencement of acquisition proceedings, and defending against legal challenges to decisions to acquire properties.

With significant experience in proceedings to determine the fair market value of properties taken by eminent domain, Mike is an integral part of trial teams for these types of valuation proceedings. To prepare for these disputes, he works closely with appraisers and other experts such as engineers, construction cost estimators, environmental consultants, and architects.

A stellar writer and drafter, Mike has prepared many appellate briefs in connection with condemnation matters and has argued before appellate courts including the Second Circuit Court of Appeals and the New York State Appellate

Division. Additionally, he has successfully defended condemning authorities against federal constitutional challenges.

Mike's trial record encompasses issues related to zoning, economic and physical feasibility, highest and best use determinations, and comparable sale analysis. He also has significant experience with judgment enforcement practices in New York state courts and the preparation and filing of public and private mechanic's liens pursuant to the New York lien law.

The project seeks to create, restore, and maintain sand dunes damaged by Superstorm Sandy along the 12.5 mile coastline of Fire Island, and involves the acquisition of hundreds of easements and dozens of fee acquisitions. Mike has been an integral part of trial teams and examined primary witnesses at multiple valuation trials.
