He is currently serving as an Adjunct Professor of Law at Columbia Law School, where he lectures on Native American Law. He is the author of numerous law review articles and has written United States Supreme Court *amicus* briefs on tribal law matters, and frequently lectures at conferences and seminars on Native American financing issues. He began his legal career at Cravath, Swaine & Moore, where he worked for many years on all manner of financings, from steel plants to casinos and hotels to ships and aircraft.
